## Parent/Guardian Consent & Liability Release Form (Page 1)

As parent/legal guardian of (child name) \_\_\_\_\_ I hereby give my permission for my child or ward to attend and participate in the activities sponsored by Peachtree Wind Ensemble (PWE).

As a condition of being able to participate in the Peachtree Wind Ensemble (PWE), the undersigned as legal guardians for the child/ward hereby acknowledge and agree that:

1. A parent, legal guardian or approved sponsor listed above **must accompany and remain with the child** during all rehearsals, performances and PWE sponsored activities; and
2. The activities of the Peachtree Wind Ensemble may involve certain inherent risks and hazards which cannot be prevented that could result in damage to property or personal injury, including death; and
3. Notwithstanding these risks, my child or ward are permitted to enter upon the activity's premises to participate in all PWE activities and assume all risks associated with the activities in which they may engage; and
4. I am responsible individually and collectively for all financial costs for any damage my child, my ward and/or I cause to Peachtree Wind Ensemble property, Fayette Friendship Community Church, other Participant's and any Activity Venues property or equipment while said Peachtree Wind Ensemble activity is in progress, and the time immediately preceding and following said activity; and
5. Child or ward have no medical condition or health problem which prevents their participation; and
6. The undersigned is responsible for arranging transportation for said child or ward to and from rehearsals, performances, and activities of PWE. The undersigned does also hereby give permission for said child or ward to ride in any vehicle designated by the staff of PWE while attending or participating in activities sponsored by PWE; and
7. I hereby release and hold harmless Peachtree Wind Ensemble, Fayette Friendship Community Church and any other Activity Venues; its agents, directors, officers, volunteers and employees, successors and assigns from any and all liability, claims, demands, actions and causes of actions, whatsoever, arising out of or related to any loss, damage or injury, including death, that may be sustained by said child or ward or any property while in, on or around the PWE activity's premises, and will not institute nor aid any suit or action against any of the foregoing for damage, loss or injury to person or property which may be sustained by child or ward; and
8. I hereby give permission to list said child's/ward's name and instrument on the PWE Website and Concert Programs. To include my contact information on the PWE Membership List that is distributed to the Board, Conductors, Assistant Conductors, Section Leaders and upon request, Band Members ONLY. NOTE: Members are not allowed to distribute this list to any Non-Member or use it for any purpose other than official PWE business; and
9. I also give permission to use any video images, photographs, audio recordings, or any other visual or audio reproduction that may be taken of child/ward while participating in activities sponsored by the Peachtree Wind Ensemble, to be used, distributed, or shown as PWE sees fit; and
10. The terms of this document are contractual in nature and not merely recitals and are binding upon the undersigned, his or her heirs, executors and administrators.
